- There is a 24-hour cancellation policy. Late cancellations will be penalized as a session discounted from a package, unless it was due to extenuating circumstances.
- Payment methods include: e-transfer, Cash, Credit Card, Square, PayPal.
- Receipts will be issued for each purchase.
